User Agreement

The undersigned (USERS) have read, understand, and agree to the following stipulations regarding their usage of Furlough Ministries Inc vehicles:

1. USERS must be U.S. Citizens, 25 years of age or older, with a valid U.S. Driver's License.
2. USERS agree to pay Furlough Ministries Inc \$300 for the first month at time of pickup, and each month beginning 30 days after the agreed upon vehicle release date and will continue every 30 days until the vehicle is returned (e.g. Vehicle is released on May 22, the next month's payment will be due on June 22 and so on). For any remaining days after the last completed 30 day period, the USERS agree to pay \$10 a day not to exceed \$300 per 30 day period until the vehicle is returned. The USERS are obligated to pay through the agreed upon end date even if the vehicle is returned early.
3. A new user agreement must be signed if the vehicle needs to be kept longer than 30 days after the stated return date.
4. This vehicle is for personal use by the undersigning missionaries during their furlough. The intended use is for fulfilling their commitments to visit donors and family members during this furlough period. It is not to be used for any other purpose, and will not be driven by anyone other than the USERS without express written consent of Furlough Ministries Inc.
5. The vehicle is to be used in the lower 48 United States. The vehicle is not allowed to be driven in Mexico or Canada under any circumstances.
6. The USERS agree not to operate the vehicle while under the influence of alcohol, drugs or other substances which may impair his/her ability to operate the vehicle in a safe manner. Mobile telephones will not be used by the driver any time while the vehicle is in motion. Seatbelts will be worn by all vehicle occupants whenever the vehicle is in motion and all children under 4 feet 9 inches and less than 80 pounds must be in an appropriate size car seat/booster. The USERS agree not to exceed the speed limit or drive at speeds that are unsafe for road conditions and agree to operate this vehicle in a safe, prudent and lawful manner at all times.
7. The USERS agree to only drive when rested. They agree not drive more than a total of 10 hours per day per driver. They understand that periods of uninterrupted driving should not exceed 2 hours, separated by breaks of at least 15 minutes.
8. No smoking is allowed in the vehicle at any time, and no firearms will be carried in the vehicle at any time. The vehicle will be turned off, keys removed, and doors locked when vehicle is unattended.
9. USERS are responsible for any damage to, or caused by the vehicle, and must be insurable in order to qualify for use of this vehicle. All accidents and tickets must be reported immediately. Furlough Ministries Inc will expect any drivers causing damage to a vehicle due to an "at fault" accident or negligence to pay a deductible not to exceed insurance deductible. USERS agree to sign an authorization to disclose confidential driving record information to Furlough Ministries Inc and agents acting on behalf of Furlough Ministries Inc. Any past negative information in their driving record(s) may result in the denial of usage.
10. USERS are personally responsible for any and all traffic tickets, summonses, citations, toll fees or violations during their use of the vehicle. Furlough Ministries Inc must be notified immediately if their driver's license is suspended or revoked for any reason, or in the event of any and all incidents (e.g. accidents, tickets, etc.) that could impact their insurability. The USERS understand that any future negative information in their driving record(s) may result in revocation of the privilege of driving this vehicle.

11. USERS agree to have the oil changed every 3,000 miles and tires rotated and balanced every 9,000 miles at USERS sole expense. USERS agree to keep all lights in good working order at USERS sole expense. If additional repairs are necessary or recommended, USERS must contact Furlough Ministries Inc **prior** to buying or authorizing any parts or service. Failure to do so will result in expenses not being reimbursed.

12. USERS agree to return the vehicle directly to Furlough Ministries Inc or designated representative at the end of the usage time.

13. USERS acknowledge and agree that Furlough Ministries Inc is not a manufacturer of vehicles. It is further acknowledged that Furlough Ministries Inc makes no representations, promises, statements or warranties, expressed or implied, with respect to suitability, or fitness of the vehicle for the USERS purposes or otherwise. USERS agree to indemnify Furlough Ministries INC from and against any loss, claim, demand, liability, cost, damage or expense of any kind, caused or alleged to be caused directly or indirectly by the vehicle, or by any inadequacy thereof for the purpose of or any use of, or any defect therein, or any delay in providing, or failure to provide the same, or any interruption or loss of service or use thereof, or damage whatever and however caused as a result of the use of the vehicle.
